Our stories have led to numerous positive developments in the society. Evenhanded and meticulous reporting is behind all of our stories.

We daily witness taxpayers' outrage over how government misspends their money; of officials embezzling funds from state-owned companies; of nepotism in hiring. Your tips helped us denounce corrupt politicians, police officers, judges and prosecutors, instilling a sense of hope that things will get better. It is precisely our aim to use free and independent press to right the consequences of legislative, executive and judicial powers' wrongdoing.

As the first investigative media outlet in the region, CIN strove from the beginning to introduce the highest professional standards on BiH media scene and set itself apart as an independent source of information that is not opinionated, or influenced by political rhetoric and tainted motivations.

The ever-growing increase of visits to our web page, the support we receive from citizens and nearly 40 international and domestic awards testify that media scene in BiH would be hard to imagine without CIN.

CIN has an ear for technological trends and the public needs, especially those of the younger generation. We provide our readers not only with stories, but with opportunity to discover investigative journalism through animation, infographics, video stories and comics. We have also created 18 on-line databases that contain hundreds of thousands of fact-checked information and primary source documents hitherto hidden from the public eye by government bureaucrats.

The major domestic and regional media outlets regularly publish our stories. On average, a CIN story is published in 50 different print, broadcasting and web news sites.

CIN was started in 2004 with a technical assistance and support from the New York University School of Journalism and the Journalism Development Group. Today, CIN is a modern news agency that continues to be the vanguard of highest professional standards in reporting.



Policemen and Criminals

A video story about former police commissioner in Una-Sana Canton, **Ramo Brkić**, sentenced to 11 years for production and trade in drugs, abuse of office and corruption. During this investigation, reporters conducted around 100 interviews including those with cannabis growers and drug dealers; police officials and politicians and other people of stature in the canton.

Abuse of Accommodation Allowances in FBiH Parliament

CIN reporters uncovered how members of the Federation of Bosnia and Herzegovina House of Representatives and House of Peoples took advantage of taxpayer-funded accommodation in Sarajevo.

From now on, MPs will have to prove that they don't own property holdings in the capital when applying for accommodation allowance. Prosecutor's Office in Sarajevo has opened an investigation.

Court-appointed Attorneys: Between Justice and Profit

Courts in BiH spend nearly 11 million KM annually on court-appointed attorneys. CIN reporters have documented this in a unique database and showed how some court-appointed lawyers pulled strings to get cases.



Following CIN's investigation, a judicial regulator introduced a system to track court-appointed defenses. Cantonal Prosecutors in Sarajevo opened an investigation against lawyer Omar Mehmedbašić on charges of witness tampering.

Abuse of Money Earmarked for Hiring Veterans

Through three stories and a unique database on the financing of veterans' associations and co-ops, CIN reporters revealed how money intended for veterans was misused. Presidents and founders of veterans' associations and co-ops kept the money for themselves while falsely accounting for expenses.

Life on Toxic Soil

The Tuzla Power Plant has been depositing toxic tailings in nearby settlements. Four years ago, experts found high levels of nickel, chromium, arsenic and other life-threatening toxins in air, water and soil. While reporting on a story, we found out that chemical companies also never deposited safely their toxic waste. Waste, still capable of causing illness and death, remains in factory compounds.



At the request of Tuzla Canton Prosecutor's Office, the FBiH inspectors investigated the pollution level of dumps.

Bosnalijek: Suspicious Money of Russian Investors and CEO Arslanagić's Riches

CIN reporters proved and showed how Russian investors illicitly bought shares to acquire the controlling stake in a Sarajevo drug maker Bosnalijek. We also tracked down assets worth millions which the firm's former CEO **Edin Arslanagić** and his family bought in BiH and the USA during and after his time at company's helm. We proved that they paid the assets one million KM more than had been their reported income.

Camping Around Fire Instead of Going to Prison

CIN reporters found that some convicts, including politicians, may never get to serve their prison sentences. They would delay the start of their sentence based on erroneous facts and were eventually pardoned. Most often, the reason for postponement was that prisons were too crowded. Official records show that there were 317 available places in 12 BiH prisons.

Danger on Your Plate

CIN reporters published several stories warning of the lack of adequate sanitary conditions in hospitality facilities and indoor markets around the country. As a part of the investigation, CIN had food samples from fast food joints in Sarajevo, Banja Luka and Mostar tested. The results showed that around half of the tested samples had above the normal concentration of bacteria or included toxic substances. Not long after the series was published, hundreds of people ended up in hospital due to food poisoning.

Buying a Dream House

CIN reporters uncovered that two former FBiH prime ministers, **Nedžad Branković** and **Edhem Bičakčić**, used public funds to buy Branković a luxurious apartment in Sarajevo. He chose a flat that the FBiH government and the state-owned Energoinvest paid for. Later, Branković bought out the occupancy rights for the flat worth 264,000 KM with certificates.

CIN: How did you buy that flat?

Branković: In line with the law.

CIN: How?

Branković: Well, in line with the law.

CIN: With certificates?

Branković: I bought it in line with the law.



After the story was published, Branković resigned the office of Prime Minister.

CIN reporters revealed how children in foster homes were raped, physically abused and neglected. In BiH the oversight of foster care – placing minors in the private homes – is still very loose.

Tainted Testimonies

Željko Karan, a pathologist and forensic expert witness in the RS, admitted to investigators that he had taken money to doctor evidence in cases in which he testified as a forensic witness. He later recanted his testimony and claimed that he had been set up. His testimonies have sealed the fate of hundreds of people. In at least two cases, the family members of defendants said that Karan and his colleague Milko Marić asked for money to instruct defendants or doctor evidence in their favor.

In 2018, Željko Karan emerged in the public spotlight because his inquest into the death of Davor Dragičević was found controversial.

Allowance for Accommodation in One's Own Apartment

The FBiH has spent some 226,000 KM on accommodation allowances of 13 ministers. There is no oversight of that spending that allows misuses to happen. CIN reporters have found that four ministers collected reimbursements even though they own apartments in the same towns where they work.

Politicians' Property Holdings do not Square with Their Income

Kemal Čaušević, a former director of the Indirect Taxation Authority in BiH, bought assets worth 1,080,000 KM over less than seven years.

Also, the former director of the Sarajevo Clinical Center, **Faris Gavrankapetanović**, and his family acquired property worth 2 million KM over ten year's period.

Their reported income could not have covered the expense of acquiring such an amount of assets.

Reporters also uncovered that the president of Croatian Democratic Union in BiH, **Dragan Čović** and his wife Bernadica, received most of the property either as gifts or as purchases they made before 2003. After police started investigating Čović, Bernadica started buying property in family's name — some of which she later received as gifts.


