Dear Sir,

I am addressing this issue in order to properly inform the public about the allegations made by the Center for Investigative Reporting in an article published on July 15th, 2016, on the official website www.cin.ba. I hereby inform you, and the general public, that an investigation has never been launched against me in the case mentioned in the article and, consequently, neither an indictment has been filed in relation to the case, nor in relation with any other case that would require the opening and the conduct of the investigation. Namely, the Cantonal Prosecutor's Office of the USK in Bihać, in the pre-criminal procedure, dismissed the application as unfounded and thus terminated the case and suspended all further actions in the case. Considering that you declare as an independent institution dealing with serious journalistic work, with the aim of providing verified and truthful information based on facts and evidence, I hereby ask you to adequately inform the public, note and post the act which is provided in the appendix. Specifically, I submit to you the Certificate of the Cantonal Prosecutor's Office of the USK, which confirms that no investigation has been launched against me, and consequently no indictment has been filed in connection with the case.
