

**In Bosnia and Herzegovina, court proceedings are conducted against at least 16 lawyers.** They were accused of abuse of position, document forging, organized crime and abuse of client's trust. Three of them were deleted from the Directory of lawyers, and the rest are still practicing law.

<b>BRANKO IVANKOVIĆ*</b> ŠIROKI BRIJEG	Withheld client's money.
<b>DRAGAN RADETIĆ</b> PRIJEDOR	Withheld client's money.
<b>EMINA BEGIĆ</b> BUGOJNO	Withheld client's money.
<b>EMIR KARAČA</b> SARAJEVO	In an organized criminal group, he participated in feigned court proceedings to acquire ownership of real estate.
<b>ISMET HAMZIĆ**</b> SARAJEVO	He participated in feigned court proceedings to acquire ownership of real estate.
	He organized a criminal group that assisted clients in illegally acquiring ownership of real estate.
<b>JEVTO JANKOVIĆ</b> BANJA LUKA	Withheld the client's money and insulted the judge.
	Insulting judges in letters he submitted as a lawyer.
<b>KEMO KAPUR</b> SARAJEVO	In an organized criminal group, he participated in fake court proceedings to acquire ownership of real estate.
<b>LEJLA MIRELA EMINOVIĆ</b> SARAJEVO	She used false powers of attorney in feigned court proceedings to acquire ownership of real estate.
<b>MIRSAD MEŠIĆ</b> BIHAĆ	He forged a power of attorney.
<b>MURISA MAKAREVIĆ</b> SARAJEVO	In an organized criminal group, she participated in feigned court proceedings to acquire ownership of real estate.
<b>NERMIN VILA</b> SARAJEVO	He used false powers of attorney in feigned court proceedings to acquire ownership of real estate.
<b>PREDRAG MIŠIĆ*</b> MOSTAR	Withheld client's money.
<b>SAMINA SKOPAK</b> SARAJEVO	She participated in feigned court proceedings to acquire ownership of real estate.
	She forged documents in court proceedings to acquire ownership of real estate.
<b>SANEL NEZIRIĆ</b> SARAJEVO	Aided in the commission of a criminal offense by providing an expert opinion.
<b>STOJAN VUKAJLOVIĆ***</b> BANJA LUKA	He helped a judge in the commission of a criminal offense in order to buy real estate at a more favorable price.
<b>SUAD SULJIĆ</b> TUZLA	He used the homeless and foreign nationals for economic fraud.
